Dear members of the board,

Jefferson County, the City of Madras, and the Madras Homeless Advisory Committee are excited about the opportunity to have a collaborative partnership with the Homeless Leadership Council for the 2024 Point-In-Time (PIT) count. As you are well aware, the PIT count is conducted to determine the number of sheltered and unsheltered individuals and families that are experiencing homelessness on a specific night in January. An accurate and comprehensive Point-in-Time count takes an entire community and partners to conduct, as many of our homeless population are difficult to reach and can be untrusting of formal government organizations. It is therefore essential that partners, like the Homeless Leadership Coalition, have an active and visible role with this work.

The Point-in-Time count for 2023 estimated 51 unique individuals that reported experiencing homeless on January 24, 2023, in Madras. According to local organizations, shelter operators, and homeless outreach advocates, this number is closer to half than what was expected based on ongoing services that are provided locally on a daily basis. This is a concern, as information from the PIT is frequently used to inform decisions about homelessness funding, policy recommendations, and local resources. With an inaccurate Point-in-Time count, vital resources that are needed to support our local homeless population and organizations are instead sent to other areas. For a community such as Madras, these resources are essential as there are no alternative funding sources for many of the needed local services.

The Madras Homeless Advisory is committed to being engaged throughout the planning, preparations, and conducting of the 2024 Point-in-Time count for the City of Madras. Although we are anxious to support and participate, we lack the expertise that

the Homeless Leadership Council has and will look towards you for guidance and recommendations to ensure a successful PIT count.

If there is anything the committee can do to help your efforts, please do not hesitate to reach out. Thank you again for your continuing partnership.
