OVERVIEW

The Madras Redevelopment Commission (MRC) has a Design Assistance program to assist property owners develop conceptual renovation plans for their property. The MRC provides grant funding to property owners to financially assist them develop renovation plans that are high-quality and compliant with City Codes so that any site or building improvements constructed further their efforts to revitalize the Madras Urban Renewal District.

Properties that are located in the Madras Urban Renewal District are eligible for a Design Assistance grant. Applicants are highly encouraged to select a licensed Architect and General Contractor prior to filing an application for Design Assistance grant funding. This will allow property owners to have a skilled design professional help the determine what improvements are needed and work collaboratively with a General Contractor to ensure the project can be constructed within the property owners budget and is practically feasible to construct. Ultimately, the Design Assistance grant will provide the property owner high-quality concept plans, a narrative of the planned improvements, and cost estimate for construction. This will enable the property owner to consider the scope of work and construction cost so that they can make informed decisions regarding the project and whether they need to move forward with acquiring the necessary financing for the project. Design Assistance applications will be reviewed through a Type A review process for which will be completed within 30 days of the application being filed and deemed complete.

ELIGIBILITY

- 1. The subject property is located within Madras Urban Renewal District boundary (see Map 1).
- 2. Applicants may be:
 - An Individual
 - A For-Profit Business Tenant (with written approval from the building's owner)
 - Property or Business Owner
 - A 501 (c)(3) not-for-profit or charitable organization
- 3. The building on the subject property is inadequate, degraded, or obsolete building system.

AVAILABLE FUNDING

The Madras Redevelopment Commission will allocate grant funding for Design Assistance grants in their biennial budget. The MRC will consider awarding grant funding for applications subject to funding availability. The MRC may award up to \$3,000 per application at their discretion based on the approval criteria stated herein.

DESIGN ASSISTANCE REQUIREMENTS

All conceptual designs funded by the MRC's Design Assistance program shall:

- 1. All plans, reports, studies, and otherwise funded by this program must comply with the Revitalization Toolkit, City's Development Code, Public Improvement Design & Construction Standards.
- 2. The proposal addresses poor appearance or visible deterioration that discourages investment in surrounding properties.
- 3. Exterior color scheme uses 3 or 4 colors.
- 4. Proposal includes store front windows that are transparent and Low-E.

- 5. Storefront windows include lighting designed to illuminate window displays.
- 6. Decorative exterior lighting fixtures are proposed that, include but are not limited, to sconces lighting, goose neck lighting, etc.
- 7. If appropriate with the proposed use or improvements will create an outdoor display, seating, or gathering places visible from the adjacent street(s).
- 8. There is a walkway that connects to the sidewalk in the adjacent street to the principle building entrance(s).

APPROVAL CRITERIA

Design Assistance Grants will be approved based on the following criteria:

Design Assistance applications will be reviewed through the MRC's Type A Review process which is as follows:





Figure 1. Type A Review Process
