B. Arbor Day Discussion

Michele Quinn told the Committee that items below will start the conversation and might take a couple of months to have everything planned out.

- a) Location – No decision was made there was discussion of using City Hall as our Arbor Day event. Other ideas were along Hwy 26, Schools including Metolius, areas along the trail system.
- b) Date – Arbor Day event will be held on April 26, 2024, at 11:00 a.m.
- c) Theme – We will come back with theme ideas during the February meeting.
- d) Volunteers and Planning – Michele Quinn addressed the need for everyone to be available for the planning and execution of Arbor Day we had posters that were chosen for awards last year that were never awarded their bird house. There was a discussion on whether or not we will be able to have bird houses ready for this years event. We need to check in with Bill Donaghu to see if he is still willing to make houses and if he still has access to tree saplings.

V. UPDATES

A. Hoffman Park Project

Jeff Hurd told the Committee that we are working with a consultant to begin the design of the park. We will be bringing the 10th Street extension to Council to approve the buildout that will be required for the park. The build out of 10th Street was not included in the grant. The extension of 10th Street is eligible to use SDC's on the build out.

B. City Hall Tree Selection

Michele Quinn asked the Committee about the tree selection for City Hall now that the trees have been removed. The Committee agreed that the building looks really good with out the large trees but would like to see City Hall decorated during the holiday season. There was a discussion about planting an evergreen that could be decorated during the holiday season. We will leave this topic on the agenda for future discussions.

C. Willow Creek clean up.

Michele Quinn told the Committee that staff is working with Department of Corrections (DOC) to have a inmate crew clear some of the overgrown brush out of Willow Creek. We will start the crew behind Public Works and have them work for a week to see how far they can get.

D. Yard Beautification

Patricia Spencer said that they will bring the information to the February Meeting and will hopefully have members from the Garden Club to attend the meeting.
